Senator McCain;

In response to this morning's phone calls from your Tempe office I am providing the following specific detail in reference to my April 5th 2004 request for: "All I am asking of you and your office is to compel the agencies of the Federal Government to do their job so as to preclude the continued belief that crimes can be committed, as the threat of being caught is less than the opportunity and motive to commit the crimes."

The EEOC case has been dismissed by EEOC due to color of law federal offenses which were consummated by the receipt of the dismissal in Arizona. Acts involved in this case took place in South Carolina, North Carolina, Washington D.C. and Kentucky. Jurisdiction resides in the location of the victim in a disparate jurisdiction case. I am seeking to have this government investigate and prosecute federal offenses.

I am humbly requesting that you:

1: Compel the USDOJ to uphold the law by investigating the abuses of color of law detailed to them in the Information they received in January 2004. Their rejection was without a single review of evidence offered to them. If you would like a faxed copy of that Information I will be happy to send it to you, but it is located on the CD your office has received and is printable from that media. Reference CD date 1/13/04 Document 30 and CD date 1/13/04 Document 330 and CD date 1/16/04 Document 69 and CD date 2/2/04 Document 1.

2: Compel the FBI to uphold the law by investigating the abuses of color of law detailed to them in the Information referred to them by US Attorney J. Strom Thurmond Jr. and faxed to them by me after their ignoring it for a month. FBI rejected the investigation claiming it was material referencing a prior complaint, which is not true. Reference CD date 1/13/04 Document 30 and CD date 1/13/04 Document 330 and CD date 1/16/04 Document 77 and CD date 2/9/04 Document 16 and CD date 3/12/04 Document 56.

3: Compel the FBI to conduct an internal affairs investigation into the reason and motivation for its improper manner of handling an allegation of serious federal offenses. The FBI Agent in Charge at Columbia SC has been issued a request for such investigation and has not responded. Reference CD date 8/13/02 Document 43 and CD date 3/22/04 Document 67.

4: Compel the EEOC to conduct an internal investigation into the allegations made in the Information received and confirmed by them in January 2004. EEOC, instead of investigating the allegations, ignored the allegations and placed the accused back in charge of the charge case. The accused subsequently dismissed the case and consummated the federal offenses. Reference CD date 2/6/04 Document 2 and CD date 3/16/04 Document 12.

5: Compel the EEOC to respond to the Freedom of Information Act filed with them on 3/1/04. No response has been forthcoming within the statutory requirement. Reference CD date 3/1/04 Document 36.

6: Compel the FBI to investigate the acquisition of the private secure username and password by an unauthorized person or persons provided only to Cari Dominguez of EEOC. Those credentials were used by a North Carolina private AT&T access account to attempt to enter the secure document location. Someone within the EEOC Chair's office provided secure information access credentials to a person not being the Chair. Reference CD date 1/28/04 Document 159.

7: Compel the FCC to investigate and process the complaints before it since 2002, one having been submitted five times, after the FCC ignored and misplaced the previous submissions. Reference CD date 8/13/02 Document 113 and CD date 9/23/02 Document 254 and CD date 10/04/02 Document 261 and CD date 2/11/04 Document 335 and CD date 2/11/04 Document 337 and CD date 3/10/04 Document 361.

These requests come from a constituent residing in Arizona where the act consummating the federal offenses was received. All copies of complaints and correspondences and documents of relevant evidence are contained in the CD your office has possession of.

I sincerely hope you are able to require the agencies of this government to perform their legal requirements and investigate a case that is already proven for them.
